Renewal of Registration Audit

RTO Background						

The Mountain District Women's Co-operative Ltd commenced operations in 1974 with the aim of progressing the interests of women, initially through the sale of goods and education for women and as a Neighbourhood House. The organisation registered as a Registered Training Organisation in 1995 to offer accredited qualifications to women.

The organisation recently adopted a new trading name, i.e. Mountain District Learning Centre (MDLC), in response to both females and males attending courses at the Centre. The Centre mainly provides courses for youth through VCE/VCAL programs and education for adults. The Centre programs focus on transition education, programs for disengaged learners and learners with a disadvantage.

Programs provided by the Centre are funded through ACFE program funding, HAAC program funding and HESG program funding. Fee for service courses are delivered in TAE40110 Certificate IV in Training and Assessment together with a number of short courses.

The Centre has enrolments of up to 200 learners each year.
